Partners in Policymaking® (PIP) is a leadership training program originally designed for parents of school-age children with developmental disabilities and adults with disabilities. Partners was created by the Minnesota Governor's Council on Developmental Disabilities more than 35 years ago and has since been offered nationally and internationally. Partners teaches leadership skills necessary to develop positive partnerships and working relationships with elected officials and other policymakers who make decisions about the services and supports that you and/or your family use. is accessible, informative, and empowering. The graduates of Partners often become members of boards, councils, task forces and advisory committees; some run for elected office, and some secure employment in disability advocacy or service organizations.

Partners is about **systems change**—creating, working towards, and achieving a vision of shared values about, for, and with, people with disabilities. It is based on the belief that the most effective and enduring public policy decisions are made by the people who need and use the services and supports in partnership with elected officials and other policymakers. It is about becoming confident in oneself, competent in the knowledge and information received, and comfortable sharing your life experiences and expertise that will enhance the Partners program.

Partners participants spend eight sessions building a "toolbox" of information, knowledge, and skills for communicating effectively with legislators, policymakers, and administrators. All presentations, assignments, and group activities are designed to give participants practice and experience to improve policy, supports and services systems and staff, and opportunities for full participation as a valued member belonging in their community. It is **mandatory** that participants attend every session.





### Applications will be accepted from:

- Adults with developmental disabilities, 22 years of age and older
- Parents, legal guardians, and family members (including adult siblings) of people with developmental disabilities
- Supporters in Supported Decision-Making Agreements for individuals with developmental disabilities

#### Requirements

#### To participate, the Partners program requires:

- · a commitment to attend and participate in ALL eight sessions
- an interest in learning and practicing new skills in a comfortable and safe environment
- A desire to build and strengthen a network of people from diverse cultural backgrounds and life experiences
- A willingness to learn from national and state experts who share our vision and values

- Before beginning to complete the application, please read ALL the instructions, questions, eligibility definitions, submission requirements, and important information included on the Application form.
- Applicants must complete ALL sections of the Application form and return it to by the deadline for it to be considered. Application forms must be received no later than 5 pm on Saturday, September 7, 2024, to be considered for the 2024-2025 PIP Class 6.
- Electronic submission by email is preferred. However, applications will be accepted by email or U.S. Mail. Information on how to complete and submit the application is included in the instructions on the last page of the Application.
- Participation in Partners is a commitment of time and energy and requires work outside of class time to complete homework and an Advocacy Project. Please review the calendar carefully before submitting your application.

#### **Selection Process**

A Review Committee, which includes Partners Graduates and representatives from the Illinois Council on Developmental Disabilities, selects participants based on several criteria. Class size is limited. Selection decisions will be made by Monday, September 30, 2024.

#### **Cost Information**

There is no fee to attend. Program costs are covered in part by a federal appropriation from the Administration for Community Living to the Illinois Council on Developmental Disabilities. These funds are used to carry out the Partners program for those chosen for the class.



Overnight accommodations are provided at no cost for those who drive a distance to attend. Class members are matched and housed in double occupancy rooms. Mileage/travel reimbursement will be provided to cover travel costs.

Also covered are meals, speaker handouts, resource materials, publications, and interpreter or language translation services.

Respite/Childcare & PCAs – Reimbursement up to a maximum dollar amount per weekend session is available for participants needing these services when another funding source does not pick up these expenses.

#### **IMPORTANT NOTE**

The Partners Program does not provide onsite childcare services. Family members are not permitted to stay at the hotel during the weekend training sessions unless a family member is serving as a personal assistant to a class member.
